

Terms and Conditions.

This quotation is subject to the terms and conditions appearing herein, on the reverse side, or attached to.

GENERAL TERMS

The prices quoted are in Canadian funds, F.O.B. **Aurora, Ontario.**

GST/HST and applicable Provincial sales taxes are **EXTRA.**

The prices quoted are valid for 10 days from the date of this quotation.

Cancellation charges: Orders for standard products (products ordered without alterations or modifications requested by the BUYER) may be cancelled prior to shipment from the manufacturer's warehouse provided that Justram Equipment Inc. is notified in writing of such cancellation and is paid for all costs and expenses (including overhead) incurred in performing and closing out the work plus a reasonable amount as profit.

Orders for **non-standard products** which are to be designed and manufactured to the Buyer's specifications are **non-cancellable** after the date of acknowledgement and acceptance of the order(s) by the manufacturer and Justram Equipment Inc.

Return of products: After shipment of products to the BUYER'S designated warehouse, products may not be returned for credit without written permission ("return products authorization") provided by Justram Equipment Inc. Products returned shall be assessed a restocking charge plus all costs incurred by Justram Equipment Inc to render returned products to "as new" condition suitable for sale as new or return to the manufacturer. Returned products must be securely packaged and shipped "prepaid" to the address stated on the "return products authorization" document.

TITLE

All goods sold remain the personal property of Justram Equipment Inc., notwithstanding delivery until the full purchase price has been paid to Justram Equipment Inc. Further, if payment is not made in accordance with the terms of payment such goods are subject to repossession without either notice or prejudice to any other rights and remedies available to Justram Equipment Inc.

TERMS OF PAYMENT

The prices quoted are based on receipt of payment within 30 days from the date of the invoice, on approved credit in good standing.

If shipment is postponed for any reason at the request of the BUYER, payment of the outstanding contract value shall be due on notice from Justram Equipment Inc. that the said equipment is ready for shipment. Handling, moving, storage, insurance and other charges thereafter incurred by Justram Equipment Inc. with respect to said equipment shall be for the account of the BUYER and shall be paid by the BUYER when invoiced. Finance charges, calculated at the rate of 2% per month (26.82% per annum) will be charged to accounts over 30 days.

Payment by Visa or Master Card is accepted – additional charges may apply for high amount orders.

SHIPMENT

All ship times are subject to sales gained by the manufacturer prior to receipt of an order resulting from this quotation. Please refer to the quote for delivery times. Since the ship date may change according to the time an order is placed, Justram will provide the manufacturer's shipment schedule once a firm order date is established.
